**TO APPRAISE THE COUNCIL REGARDING SMT V. AMOUDA, SENIOR TECHNICAL ASSISTANT [COMPUTER] HOLDING THE POST OF LECTURER / ASSISTANT PROFESSOR ON CONTRACT BASIS IN THE CENTRE FOR BIOINFORMATICS / MSC. COMPUTATIONAL BIOLOGY OF THE UNIVERSITY FOR MORE THAN EIGHT YEARS AND HER REQUEST FOR CHILD CARE LEAVE**

Smt V. Amouda is a permanent employee of this University and is holding the post of Senior Technical Assistant [Computer] on regular basis w.e.f. 06-08-2004. She was selected for the post of Lecturer in the Department of Banking Technology on contract basis and therefore relieved from the post of Senior Technical Assistant w.e.f. 13-02-2008 FN on lien. Subsequently she has been selected by a duly constituted Selection Committee and joined as Lecturer in the Centre for Bioinformatics w.e.f. 03-04-2009 for a period of five years under the specific DIT scheme. The appointment to the post of Lecturer [on contract basis] at Centre for Bioinformatics was treated as on deputation, though the period exceeds five years as the post held by her was within the University itself. As regards this case is concerned, the borrowing and lending organization is one and the same.

The E.C. has ratified the continuation of engagement of Dr V. Amouda as Assistant Professor [on contract] in M.Sc Computational Biology programme w.e.f. 01-10-2013 until further orders, consequent upon stoppage of assistance for DIT. Subsequently the DBT has approved continuation of M.Sc. Computational Biology programme for further period of five years from April 2012 to March 2017. Hence, Dr V. Amouda has been engaged under this programme w.e.f. 01-10-2013 until further orders and the same was ratified by the E.C. vide Resoln. No.2013.117.153 dated 22-11-2013.

Dr V. Amouda is holding the regular post of Senior Technical Assistant on lien w.e.f. 13-02-2008 and the period of deputation approved by E.C. was ended on 02-04-2014. As per deputation rules, the normal period of deputation should not exceed five years. Now in the recent OM dated 17-02-2016, the DoPT has extended the tenure of deputation up to seven years and the delegation of powers is vested

on lending / borrowing organization in case of deputation. In this case, eight years has already been completed. A nutshell report on her service details is furnished hereunder.

Meanwhile, Dr V. Amouda has requested for Child Care Leave for six months from June to December 2015 to take care of her daughter studying in 12<sup>th</sup> Std. When the matter referred to the Centre Head, Bioinformatics he has refused to offer his views on Child Care Leave as there is a procedural lapse occurred in her appointment as Assistant Professor in M.Sc. Computational Biology Programme on contract basis. Hence the issue was referred to the Legal Cell for which the Legal Cell has advised to place the matter before the Executive Council.

The E.C. is hereby appraised the above position and is requested for directions on the following:-

- (i) The University has given further extension of deputation in the post of Assistant Professor [on contract] w.e.f. 03-04-2014 as the DBT has approved the continuation of M.Sc. Computational Biology programme up to March 2017 and whether the existing status on contract may be continued up to March 2017.
- (ii) She is holding the lien status in the post of Senior Technical Assistant, and therefore filling up the post of Senior Technical Assistant could not be done on regular basis and therefore the person who is replaced in the place of Dr V. Amouda (as Senior Technical Assistant) may be permitted to continue on contract.
- (iii) Whether she may be granted CCL taking into account of substantive position in the post of Senior Technical Assistant instead of considering her current status as faculty on contract.

**TO CONSIDER THE REQUEST OF DR. C. ARJUNAN, ASSISTANT PROFESSOR AND DR. A. PANDU, ASSISTANT PROFESSOR OF DEPARTMENT OF MANAGEMENT, PONDICHERRY UNIVERSITY COMMUNITY COLLEGE FOR ALLOTMENT OF PH.D. CANDIDATES UNDER THEIR SUPERVISION**

The Principal i/c, Pondicherry University Community College has submitted a proposal for allotment of Ph.D. candidates in Management to their faculty members who have been recognized as research supervisors by the University. The Principal has also forwarded the request letters of Dr. C. Arjunan and Dr. A. Pandu, Assistant Professor, Management Studies of Pondicherry University Community College, who have requested to allot Ph.D. candidates under their supervision as they are recognized guides of Pondicherry University.

The views/remarks from the Head, Department of Management Studies had been requested in this regard. The Head, Department of Management of Studies has informed that since these two faculty members are in UG teaching college, they cannot be considered in Department of Management Studies.

Meanwhile, the Principal has sent another letter to the Dean, School of Management requesting allotment of Ph.D. research candidates for the two PUCC Management faculties wherein the Dean, School of Management has remarked that there are precedents that an Assistant Professor of Computer Science, Pondicherry University Community College is allotted students for Ph.D. under her guidance. Hence, the request has been forwarded to the University authorities for taking a uniform administrative decision in the matter of allowing the Community College faculties to supervise the Ph.D. scholars in the University Departments.

Therefore, the matter is placed before the Council for consideration and taking a policy decision for allotting Ph.D. candidates in the Department of Management Studies to Dr. C. Arjunan, Assistant Professor and Dr. A. Pandu, Assistant Professor of Pondicherry University Community College.



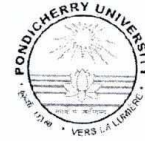

## MEMORANDUM OF UNDERSTANDING OF COOPERATION

On the other hand,

IT HAS BEEN AGREED AS FOLLOWS:

### Preamble

The Agricultural university – Plovdiv, Republic of Bulgaria and the Pondicherry university (hereinafter jointly referred to as the parties) have agreed to collaborate on various education and research programs in order to mutually enhance the skills and experience of the teachers and increase the skills of students from each university.

Both universities have decided to promote an international cooperation on a basis of friendship, equality and mutual assistance. As a result, the Parties have agreed to conclude an agreement on educational and/or scientific cooperation.

#### **Article 1: Purpose**

This memorandum of understanding is intended to define the modalities of cooperation between the signatory institutions.

The relationship between the parties is governed in descending order of hierarchy by the following texts:

- This memorandum of understanding of cooperation and, if required:
- “Students Exchanges”
- “Cooperation Program”
- “Research Cooperation”
- Any other specific cooperation program which the parties decide to conclude, in particular the establishment of degree programs.

Given the evolving nature of their relationship, the Parties may decide to conclude, upon the signature of this Memorandum of understanding, one or more of the above-mentioned cooperation, or conclude them progressively as their scientific and educational links are developed.

#### **Article 2: academic disciplines of the cooperation**

The cooperation concerns the following disciplines:

- **Agro Ecology**
- **Environmental Protection**
- **Environmental Toxicology**
- **Agro Forestry**
- **Organic Farming, Tissue culture and Biotechnology**
- **Sericulture**
- **Sustainable agricultural technologies**
- **Agri-Business**
- **Plant protection activities, etc.**

The parties may decide by a common agreement and an addendum to this Memorandum of understanding, to extend its effects **to other fields of life sciences and humanities** taught in their institutions.

**Article 3: Nature of the cooperation**

In accordance with the laws and regulations in force in each country and to the extent of their means the Parties shall promote and develop:

- Joint research activities
- The organization of conferences and seminars
- Publications
- The exchange of the professors and researchers
- The exchange of students
- The co-direction of doctoral thesis
- Any other action that the parties decide to undertake upon a mutual agreement.

**Article 4: Financial conditions**

It is understood between the Parties that this Memorandum of understanding shall in no case be interpreted as creating any financial obligation towards the other Party. The Parties shall implement together any feasible effort to obtain adequate funding in order to carry out joint projects they wish to implement in the context of this Memorandum of understanding.

**Article 5: Coming into force and terms of the cooperation**

1. This MOU is subject to ratification by the authorities of each institution according to the applicable procedures in each country. It will, therefore, become effective as of the date of its signature by the competent authorities of both institutions.
2. When this contains one or more cooperation programs, it shall specify the concerned disciplinary fields, its nature and objectives, as well as the practical arrangements for its implementation.
3. Each party will appoint a person in charge of the cooperation program who shall ensure its preparation, implementation, and evaluation.

**Article 6: Period of Agreement**

This Memorandum of understanding is concluded for a period of FIVE (5) years, unless terminated, without prejudice to actions previously undertaken. It is renewable upon written agreement of both Parties for a period that the Parties shall determine on renewal. The renewal of the agreement shall come into force under the same conditions as those stipulated in Article 5 & 1 above.

Any amendment to this Memorandum of understanding can only originate from an exchange of letters between the Presidents of the institutions.

**Article 7: Disputes**

The parties shall endeavor to reach an amicable settlement of any dispute that may arise concerning the validity, interpretation, performance or nonperformance, interruption or termination of this Memorandum.

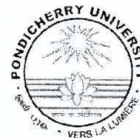
In case of failure to reach an amicable settlement, the parties agree to terminate this MOU.

The representatives of the Central Council for Research in Siddha(CCRS), Ministry of AYUSH, Govt. of India, Chennai has conveyed for possible collaboration with Central Council for Research in Siddha(CCRS), Ministry of AYUSH and Pondicherry University to undertake collaborative, training and clinical studies for establishing evidence based medical system in Siddha.

The draft MOU sent by the Central Council for Research in Siddha(CCRS), Ministry of AYUSH, Govt. of India was examined and approved by the MOU Evaluation Committee. The final draft MOU is enclosed.

**MEMORANDUM OF UNDERSTANDING**

M.1.1 This MEMORANDUM OF UNDERSTANDING (hereinafter referred to as MoU) is made entering into force this \_\_\_day of \_\_\_\_, Two thousand and sixteen between Central Council for Research in Siddha (CCRS), Ministry of AYUSH, Govt. of India situated at Arumbakkam, Chennai- 600 106 represented by its Director General hereinafter referred to as '**CCRS**' of the First Part, (which expression shall where the context so admits, mean and include its successors, representatives and permitted assigns)

**And**

M.1.2 Pondicherry University (A Central University, established under 'University Act 1985' Govt. of India.) situated at Kalapet, Puducherry-605014 represented by its Vice Chancellor hereinafter referred to as 'PU' which expression shall where the context so admits, mean and include its successors, representatives and permitted assigns of the Second part,

**M.2. Preamble:**

M.2.1. Whereas the CCRS a SIRO organization with its five units working for promoting and conducting multi-disciplinary clinical, drug and literary research in Siddha system of medicine and is engaged in developing research standards in Siddha. CCRS also has the mandate of conducting training activities and there by updating the knowledge of Siddha medical community on par with scientific developments. It has scientists in the disciplines of Siddha and allied basic medical sciences. It has infrastructure and laboratory facilities for research activities and a dedicated laboratory for drug analysis and standardization of Siddha drugs.

M.2.2 Whereas PU being is a premier teaching and research institution with a student strength of 6000 accommodated in 15 schools and 38 departments and 11 centers. PU has regular teaching and research faculties, for P.G. and doctoral courses in different fields of science, humanities and management with necessary infrastructural facilities.

AND WHEREAS it has been decided by CCRS and PU to enter into an MoU so as to undertake collaborative research, training and clinical studies for establishing evidence based medical system in Siddha.

M.2.3 It has been decided that the CCRS enter into an Memorandum of Understanding (MoU) with PU to undertake collaborative research and training activities.

M.2.4. Whereas both CCRS and PU are convinced about the mutual benefit of forging formal linkage to develop new collaborative research and teaching programs in the areas of Fundamental Research, Clinical Research, Health Care Research Programme, Nutraceutical Research, Drug Discovery and Literary Research, training of faculty members and sharing of faculty members' expertise etc.

NOW, THEREFORE, IN CONSIDERATION OF THE PREMISES AND MUTUAL COVENANTS HEREINAFTER CONTAINED, THE PARTIES HERETO AGREE AS FOLLOWS.

### **M.3. Scope of Work and Responsibilities:**

M.3.1. Both the party of the First Part and the party of the Second Part have mutually agreed to have an understanding for collaboration in the following areas of interest:

The two institutes after considering their objectives and strengths have agreed to have an understanding for collaboration in the following areas of interest:

- Joint Research & Development, projects in the areas of Drug formulations, Efficacy of drugs, Establishing diagnostic methods and other areas of basic medical and allied sciences research to be funded by external funding agencies;
- Postgraduate and Doctoral Research Project work and training to be carried out at both PU and CCRS;
- Organizing and participating in Joint Symposia / Conferences / Workshops / Short-term Refresher courses conducted by both the organizations;
- Short term and long term developmental programs on topics of mutual interest;
- Medical and technical consultancy activities of mutual interest; Exchange of faculty for guest lectures.
- Extending pre-clinical toxicology and pharmacokinetics/clinical trial facilities/trials for bio-products developed by CCRS and PU; and
- Extending access to library and knowledge sharing facilities mutually for both students and faculty in both the institutions.

M.3.2. Specific terms, conditions and procedural aspects of collaboration including financial obligations of either party shall be finalized on mutual discussion in respect of each specific project under this MoU separately.

M.3.3. The overall arrangements (type of project, approaches, training components, supervision etc.) for each collaborative activity, including the respective budget and financing schemes need to be summarized in a project

document and agreed upon by CCRS and PU and all the partners concerned before the start of such activity. This includes ethical and other clearance procedures, including Intellectual Property Rights and scientific publication. Number and names of scientists / students can be proposed by CCRS and PU.

M.3.4. A four member Joint Steering Committee (JSC) shall be constituted with two members each nominated by CCRS and PU. The JSC would identify the specific areas/activities, co-ordinate the joint project activities and finalize the terms and conditions thereof.

#### **M.4. Confidentiality**

M.4.1 Both parties hereunder agree that any information disclosed by one party to the other shall be maintained as 'proprietary confidential information' and will be disclosed only to the authorities as required in the relevant statutory regulations and to those persons in the recipient party's organization on need-to-know basis for the purposes authorized by the relevant agreement. All such proprietary confidential information will be kept in confidence and the party receiving the confidential information agrees to prevent the disclosure to any other person or persons outside the organization or any unauthorized person or persons except to the organization authorized by either of the parties hereto on need-to-know basis for the execution of the work.

The obligations that are created under this MoU on either party as well as through subsequent relevant agreements on either party shall be duly discharged during the term of the MoU/Agreement and after their expiry/termination as specified therein.



## **M.5. Intellectual Property Rights Protection**

M.5.1 A two-member sub-committee on Intellectual Property management under the JSC, will be constituted to monitor the Intellectual Property elements on case-to-case basis. This sub-committee will consist of one member each from the JSC each from CCRS and PU.

M.5.2. Both parties shall not file any application for seeking Intellectual Property Rights on their own name or in the name of its associates or any other person(s) on any matter relating to the information disclosed to each other under this MoU. However, they can seek Intellectual Property Rights in their joint names as may be mutually agreed on case-to-case basis.

M.5.3. Intellectual property generated during the activities under the MoU shall be shared jointly. The extent of ownership shall be decided mutually depending upon the relative intellectual inputs made by the parties. The expenditure incurred and to be incurred for the maintenance of IPR shall be borne by each party equally or in proportion to the extent of ownership and may be decided by the sub-committee on Intellectual Property management under the JSC.

## **M.6 Publication**

M.6.1. Publications, if any, in respect of the activity under this MoU shall be in the names of personnel involved from both the parties. Further, there can be individual publications from the two institutions. This will be in accordance with the International Committee of Medical Journal Editors (ICMJE) guidelines for authorship by mutual agreement between the institutions and cleared by the JSC. In all publications (paper, reports, etc.,) it

shall be duly acknowledged that the work has been jointly carried out by CCRS and PU under this MoU.

### **M.7. Evaluation**

M.7.1 The JSC will assess the collaborative programme and review the progress reports and the operational plans systematically through a formal meeting once a year. In addition, representatives of the institutions will make regular site visits, based on respective operational plans.

### **M.8. Duration**

M.8.1 This Memorandum of Understanding shall be valid for a period of Five years from the date of signing of the same and thereafter can be renewed for further periods subject to such other terms and conditions as may be mutually agreed upon.

### **M.9 Termination**

M.9.1 Notwithstanding Clause 8, this MoU may be terminated by either party by giving three months' notice in writing to the other party. Either of the parties shall honour within a mutually agreed period, the outstanding commitments, if any, as on the date of termination.

### **M.10 Notices**

M.10.1 All notices and other communications required to be served on CCRS under the terms and this MoU, shall be considered to be duly served, if the same is delivered at or posted by e-mail or registered mail to the CCRS at its office at Anna Hospital Campus, Arumbakkam, Chennai-600 106. Similarly, any notice to be given to the PU shall be considered as duly served, if the

same is delivered at or posted by e-mail or registered mail to the PU at its registered office at Kalapet, Pudhucherry-605014. The e-mails may be downloaded, printed and archived as and when deemed necessary.

#### **M.11 Jurisdiction**

M.11.1 All legal disputes shall be subjected to the jurisdiction of the courts in Chennai, State of Tamil Nadu, only.

#### **M.12 Modification**

M.12.1 No modification to this MoU shall be binding unless made in writing and signed by both parties.

#### **M.13 Force Majeure**

M.13.1. Any of the parties hereto shall not be released from its obligations for any reason except for force majeure such as war, strike, fire, acts of God or other causes beyond the control of the parties.

#### **M.14 Arbitration**

M.14.1. In the event of any dispute or difference between the parties hereto, such differences shall be resolved amicably by mutual consultation. Where it could not be resolved so, then it shall be referred to arbitration of two arbitrators, one to be appointed by each party to the dispute and in case of difference of opinion between the said two arbitrators, then to an umpire appointed by the said two arbitrators. The decision of the said arbitrators or Umpire as the case may be shall be final and binding on both parties. The venue of arbitration shall be at such place as may be fixed by the arbitrators

or umpire and the arbitration proceeding shall be as provided under the Arbitration and Conciliation Act, 1996.

## ADDENDUM TO THE GENERAL AGREEMENT OF COOPERATION

Between

represented by the President, Guy CATHELINEAU, duly authorized, for the benefit of the **Graduate School of Management (Institut de Gestion de Rennes, IGR-IAE of Rennes)**, located 11 rue Jean Macé 35000 RENNES, represented by its director, Mr. Laurent BIRONNEAU

and

### **The Pondicherry University**

A Central University, funded by University Grants Commission, established by an Act of Parliament No.53 of 1985, Government of India,

Headquarter is located at: Dr. B.R.Ambedkar Administrative Building, R.V. Nagar, Kalapet, Puducherry, India – 605 014

Represented by the Registrar, Dr. M. Ramachandran, duly authorized, for the benefit of the **School of Management, Pondicherry University (SOM-PU)** located at School of Management Building, University Campus, R.V. Nagar, Kalapet, Puducherry, India – 605 014, represented by its Dean, **Dr. G. Anjaneya Swamy.**

Hereafter known as « the Parties »

Based on the relationship between both institutions, it is agreed as follows:

### **1. OBJECTIVES**

- a) The general objective of this agreement is long term research and educational collaboration in fields which are compatible with the orientation of each institution, and which are relevant to the industrial, social and cultural interests and needs of the countries wherein the parties are respectively located. Long-term collaboration in the area of research will be subject to a further implementation agreement.
- b) The initial focus will be collaboration through student and faculty exchanges.



## 2. GENERAL RULES on mobility student hosting

- a) Students participating in the exchange will be integrated into the host institution as regular students, and will be subject to the student rules and regulations of the host institution.
- b) Students participating in the exchange will not be charged tuition by the host institution. This agreement is based on reciprocity. Each student will register and pay tuition fees at her/his home institution, but will enjoy the privileges bestowed upon the students at the host institution.
- c) Participating exchange students will be required to carry adequate health insurance and to provide proof to the host institution that their insurance will cover the cost of health care during the period of exchange. The students will be required to register with basic national student medical insurance coverage on arrival.
- d) Neither **SOM-PU** nor IGR-IAE will be responsible for the cost of room, board, travel or other personal expenses (including books). The participants will be responsible for these costs.
- e) Individual direct applications of students from IGR-IAE and SOM-PU can be accepted out of this agreement. In this case students can be admitted to participate in the host institution programs as regular local students with no fees exemption and will take the normal local exams with a degree goal.
- f) Each institution will assist arriving students to secure suitable housing for the period of time that they will be on campus. The housing renting confirmation should be provided upon their acceptance by the partner university as required by visa application. According to the renting rules in France, foreign/Indian students, before their coming to France, must confirm themselves the renting by providing all necessary documents and costs.

## 3. STUDENTS EXCHANGE

- a) Students participating in the exchange will be selected by their respective schools according to criteria established by the host institution. Individual direct applications of students will not be accepted as part of this exchange agreement.
- b) Up to 4 Masters Programme students from each university may take part in the program for one semester of each academic year or 2 students for the entire academic year. A meeting is organized (in person or virtually) to ascertain potential for exchange so that both sides can be adequately prepared.
- c) If either institution is not able to send the total agreed number of students in any year of the agreement, then the institution will be eligible to send additional students, equal to the deficit, in any subsequent year of the agreement.
- d) Students from both institutions must have their course selections approved by their home department and appropriate academic authority in order to obtain transfer of credits.
- e) The students will be registered as exchange students on a transfer of credits basis, spending one semester at the partner university. Therefore, they will not seek the award of a degree. However, they can be awarded a certification issued by the partner university.



#### 4. FACULTY EXCHANGE

Both the SOM-PU and IGR-IAE encourage their faculty members to teach at the partner university.

- a) According to the need of each university we will arrange for members of its faculty to visit the other university, for research purposes and/or teaching.
- b) The principle budget breakdown is as follows :

##### Expenses covered by the host university for visits including a teaching period:

- International round travel : "visiting professor" status given to the foreign professor who will receive Per Diem
- Assistance for housing
- Necessary support for teaching (min 6h per week) and research
- Office space on campus (shared office)

##### Expenses on Research Projects

- Both parties will try to seek for some funding to support the international travel and accommodation.
  - Both parties should provide necessary support for researches, one office or shared office space.
- c) Provisions concerning the period and duration of the visits, the number of teaching hours, the curriculum, the courses will be specified by the two universities prior to each visit.

#### 5. Diplomation

Both the **SOM-PU** and IGR-IAE agree on the idea of exchanging students enrolled in their home university Master Degrees. The students will be registered at the Partner University seeking for the Master's degree graduation if they would like to stay at the partner University for at least one year, and meet all the degree requirements established by the partner university. They must pay the fees charged by the host university.

- a) Students from **SOM-PU** as their home university will obtain an English taught Master of Finance, or Master of Business Administration in International Management, or Master of Marketing, or Master IN HRM at IGR-IAE. Students fluent in French language (B2 level required) can prepare a Master degree taught in French as the MAE (Master Administration des Entreprises).  
The selected students from **SOM-PU** will be students having validated a 3 year Bachelor at the home university.





b) The selected students from IGR-IAE will be students having validated a 4 year Bachelor at the home university.

Students from IGR-IAE as their home university will obtain a **Master of Business Administration, Tourism Studies, Banking Technology, International Business and Insurance Management** (at Karaikal Campus) at main campus of Pondicherry University.

## 6. COORDINATION

The French coordinator of the present agreement of cooperation for planned duration will be **Marc GAUGAIN**, Director of International Affairs of the Graduate School of Management, IGR-IAE - University of Rennes 1. The Indian coordinator of the present agreement of cooperation will be **Dr. Y.Venkata Rao**, Department of Tourism Studies, Pondicherry University.

## 7. DURATION, AMENDMENT, REVIEW AND TERMINATION OF AGREEMENT

This agreement shall be in force and binding upon the parties for a period of **five academic years**, starting on **January 2016**. Any renewal of this Agreement after the initial term requires written approval of the respective authorized representatives of both Parties. It shall be subject to revision or modification by mutual written agreement.

The Agreement may be terminated upon request of either institution, provided such request is made in writing at least six months before termination is to become effective. Any termination must take into account the right of the students already participating or accepted for any exchange to complete their stay.

In the event of ambiguous interpretation or misunderstanding on the application of the present agreement and of its implementing agreements, the parties will endeavour to reach an amicable settlement rapidly. They may, if they so wish, have recourse to reconciliation in order to reach an agreement. However, if the disagreement persists, a final and definitive settlement will be reached under the rules of arbitration of the International Chamber of Commerce by one or more arbitrators appointed in accordance with this regulation.

This present agreement will be written in three languages, **French, Tamil and English**. The English version is considered as the authentic and original version.

## Agreement relating to the degree program organization

Both the **SOM-PU** and IGR-IAE agree on the idea of exchanging students on a Master Degree basis. The students will be registered at the Partner University seeking for the Master's degree awarding if they would like to stay at the partner University for at least one year, and meet all the degree requirements of the partner university.

### ARTICLE 1

After being selected at their home university, the selected students from **SOM-PU** will be students having validated a 3 year Bachelor at the home university ; after the selection by the home university they will follow a specific one year preparation program in management and additional courses of English or French language.

After receiving approval from the Rennes Head of the Master these students are admitted to study as regular students at the University of Rennes 1. To receive the Master degree of the University of Rennes 1, IGR-IAE, the students have to pass successfully the regular examinations of one of the Master programs of the University of Rennes 1 at the end of the academic year (see Article 2 as well).

### ARTICLE 2

To successfully complete their studies, students from **SOM-PU** enrolled in the degree program have to acquire 60 ECTS points of the IGR-IAE Master. The students have to collect these ECTS points within one year at University of Rennes 1.

After successfully completing the remaining examinations the students from **SOM-PU** receive the Master of the University of Rennes 1.

### ARTICLE 3 : only if it could be possible for Rennes students to prepare a SISU Master degree in english

Students from IGR-IAE as their home university will obtain a Master of Business Administration (MBA) or Master of International Business at **SOM-PU**.

The University of Rennes 1 sends students who are enrolled in a Master program, and make a break between Master 1 and Master 2 in Rennes, to **SOM-PU**. After being selected in their home university, and after receiving approval from the Head of the Master program in **Business Administration, Tourism Studies, Banking Technology, International Business** and **Insurance Management** (at Karaikal Campus), these students are admitted to study as regular students at **SOM-PU**. They take courses from the Master program.

The students from University of Rennes 1 have to acquire credit points at **SOM-PU**. Only after having completed a Master from the University of Rennes 1, students who studied at **SOM-PU**





receive both national degrees (the Master of the University of Rennes 1 and the Master of **Business Administration, Tourism Studies, Banking Technology, International Business and Insurance Management** (at Karaikal Campus)).

#### ARTICLE 4

The exchange students of the respective partner university are on a par with the students of the respective host university; no par is required for degree students who will pay tuition fees to the home university and will be responsible for their own travel and subsistence expenses. They have to obey the enrolment regulations of their host university.

The host university will assist the students in finding housing if, possible on student concessional cost.

The host university supports the students involved in this cooperation in such a way to facilitate the organization of their stay.

#### ARTICLE 5

The selection of designated students is incumbent on the home university, subject to the host institution's agreement. After being selected at their home university, the selected students from **SOM-PU** will be students having validated a 3 year Bachelor at the home university ; after the selection by the home university they will follow a specific one year preparation program in management and additional courses of English or French language

This selection is based on criteria developed by representatives of the two cooperating universities. Students from **SOM-PU** have to have advanced knowledge in the French or English language (Level B2 required); students from IGR-IAE have to have advanced knowledge of the English language (Level B2 required); the language skills will be assessed by the home university.

#### ARTICLE 6

Students participating in the exchange program have to participate in the examinations of the host university.

Examinations and ECTS or **CREDIT** points will be acknowledged by the signing universities according to their relevant examination regulations. The students will receive a supplement to the diploma certificate from the host university.

#### ARTICLE 7

This agreement will come into effect on **1 January 2016**, for the duration of 5 years. After this time period, it will be decided to what extent this program will be continued.



#### ARTICLE 8

In the event of ambiguous interpretation or misunderstanding on the application of the present agreement and of its implementing agreements, the parties will endeavour to reach an amicable settlement rapidly. They may, if they so wish, have recourse to reconciliation in order to reach an agreement. However, if the disagreement persists, a final and definitive settlement will be reached under the rules of arbitration of the International Chamber of Commerce by one or more arbitrators appointed in accordance with this regulation.

#### ARTICLE 9

The contracting parties will consult with each other as often as necessary, but at least once a year to evaluate the program. Every modification of this treaty needs the agreement of the responsible persons of both universities.

**TO RATIFY THE RECOMMENDATIONS OF DEANS COMMITTEE MEETING HELD ON 23/10/2015 ON THE ITEM OF ISSUE OF DEGREES TO THE QUALIFIED STUDENTS OF 2012-13 BATCH.**

The 23<sup>rd</sup> convocation was held on 25<sup>th</sup> September 2013, in which grace was passed for the students who have qualified during 2011-12. After that Convocation could not be held for subsequent years for various Administrative reasons and there were grievances from the students for issue of degree certificates for study/employment purpose. In these circumstances, to find a way out to help the students, Deans committee met on 23<sup>rd</sup> October 2015 and it was decided as follows: (minutes enclosed)

“The Registrar (i/c) and Controller of Examinations informed that Convocation has to be conducted for three academic years viz, 2012-13, 13-14, and 2014-15. Among the three years, for the academic year 2012-13, grace has already been passed by the Academic Council and Executive Council and for the remaining two years, grace has been passed in Academic Council and Executive Council vide No.2016.76.39 and 2016.120.05. Also informed that around 900 students (Gold Medallists and PhD scholars) will be attending the Convocation, when all the three years students are clubbed together.

After elaborate discussion, it was decided that for the year 2012-13, the Gold Medals will be distributed by the Deans of Schools in a small function organised for the purpose at the School level itself. The Degree certificates will be sent to the HOD's office / affiliated colleges for distribution to the candidates.

For the academic years 2013-14 and 2014-15, Convocation could be arranged to be held at Rajiv Gandhi Stadium, if not at JN Auditorium.

Accordingly arrangements are being made now to hold the convocation shortly for the students who have qualified up to 2015 batch.

In this regard, instead of distributing gold medals at school level, it is suggested that candidates may be admitted in the ensuing convocation for all the three years from 2013 to 2015 and Gold Medallists of 2015 batch alone may be invited to attend the function to receive the Gold medals/Award certificates along with Ph.D. awardees of 2015 and up to July 2016. The Gold Medallists of previous two batches of 2013 and 2014 may be informed after the convocation, to come and collect the medals and certificates from the Controller of Examinations office / or a small function could be organised for distributing the same prior to convocation.

The following agendas were taken up for discussion:

1. Convocation

The Registrar (i/c) and Controller of Examinations informed that Convocation has to be conducted for three academic years viz., 2012-13, 2013-14 and 2014-15. Among the three years, for the academic year 2012-13, grace has already been passed by the Academic Council and Executive Council and for the remaining two years, grace has to be passed. He also informed that around 900 candidates (Gold Medalists and Ph.D Scholars) will be attending the Convocation, when all three year(s) students are clubbed together.

After elaborate discussion, it was decided that, for the year 2012-13, the Gold Medals will be distributed by the Deans of Schools in a small function organized for the purpose at the School level itself. The Degree Certificates will be sent to the HOD's office for distribution to the candidates.

For the academic year 2013-14 and 2014-15, Convocation could be held and could be arranged at Rajiv Gandhi Cricket Stadium.

2. Conduct of Entrance Examination


Entrance Examination will be conducted through online mode. The question paper will be of objective type.


It was decided that from this academic year, question papers will be set by external experts, for which Rs.5,000/- will be paid as remuneration per question paper including key. The Head of the Department will submit an outline of syllabus and panel of examiners to the Controller of Examinations through the Dean's Office. 200 questions will be set by the external expert, the soft copy of which will be checked by the Head of the Department concerned.

For Ph.D admissions, 70% of weightage will be given to entrance examination and 30% for interview. This weightage for interview will be decided at the Department level whether it should be 30% or it should be 15% for a short written exam and remaining 15% for interview. Systems Manager suggested that weightage might be given separately for analytical skills and reasoning etc.


