GROUP-B:

The Departmental Promotion Committee for Group 'B & C' posts met on 03.12.2022 has considered promotion of Assistant to the post of Senior Assistant and Junior Assistant to the post of Assistant and recommended the same to the following employees:

Accordingly, promotion orders were issued to the above employees as per recommendation except Shri G. Ramalingam and Smt. R. Punithavathy

The promotion orders in r/o. Shri G. Ramalingam under PwBD quota and Smt. R. Punithavathy against chain vacancy were not issued since the DPC for Group 'A' posts dated 29.11.2022 has recommended to issue the promotion order in r/o. Shri A. Selvaraj, Section Officer to the post of Assistant Registrar under PwBD quota only after receipt of DoPT Order for PwBD forwarded by the UGC.

CLARIFICATION FROM UGC:

Hence, this University has sent a communication to UGC on 04.04.2023, to clarify the status of DoPT OM No.36012/1/2020-Estt.(Res.II) dated 17.05.2022 regarding reservation in promotion to PwBD **(ENCLOSURE)** and also reminder on 12.02.2024.

In response to this office reminder letter dated 12.02.2024, the UGC vide its communication dated 14.05.2024 has clarified for reservation in promotion to Persons with Benchmark Disabilities (PwBDs) as follows:

"The reservation in promotion shall be in accordance with such instruction as are issued by the appropriate Government from time to time".

The appropriate Government has already issued instruction vide DoPT OM dated 17.05.2022 that in case of promotion from Group 'C to Group 'B and within Group 'B', 4% of total number of vacancies shall be reserved for PwBDs.

In accordance with above instruction, after assessing suitability of Shri G. Ramalingam recommended him for promotion to the post of the Senior Assistant in PwBD category respect to forwarding of these instruction by UGC and also Smt. R. Punithavathy recommended her for promotion to the post of Assistant against the chain vacancy.

In view of UGC having forwarded the same, the recommendation of DPC in respect of above employees as already placed before the 148th EC meeting are re-submitted for approval to implementation.

MATTER COVERED UNDER AGENDA NOTES THAT WERE SENT AS SECOND SET:

60.11 TO APPRISE OF THE IMMEDIATE REQUIREMENT OF SPECIAL GRANT FOR PURCHASE OF BUSES IN VIEW OF NON-RENEWAL OF ROADWORTHINESS OF ALL THE EXISTING BUSES.

Ministry of Education Comments:

"May be discussed and decided during the meeting keeping in view the strict compliance to the guidelines issued by Department of Expenditure and provisions contained in GFR 2017 for purchasing and renewal of vehicles."

Comments of the Integrated Finance Division of the Ministry of Education:

"Detailed proposal may be sent to Ministry of Education through UGC for consideration."

The Chairman of the Committee apprised the unique circumstances governing the University due to which University has been operating owned buses instead of outsourcing the transportation and the continuous necessity of continuing with the same arrangement in view of stalling of its fleet due to abrupt change in legislation thereby preventing renewal of roadworthiness beyond period of 15 years. Ministry officials suggested for sending the detailed proposal by enclosing tabulated comparative statement showing expenses on transport by direct ownership of the fleet and by outsourcing the service.

After detailed deliberation and after considering the steps taken by the University in meeting the transport requirements of the students, the Committee agreed and resolved that in view of the bona fide and pressing requirement, proposal should be sent to the Ministry through UGC for favorable consideration by the Ministry.

60.12 TO APPRISE OF THE IMMEDIATE REQUIREMENT OF SPECIAL GRANT FOR MISCELLANEOUS URGENT SPENDING OF CAPITAL NATURE

Ministry of Education Comments:

Comments of the Integrated Finance Division of the Ministry of Education:

The Committee thoroughly deliberated the fund requirement for each specified purpose, as briefly tabulated hereunder and as detailed in Annexure II of supplementary agenda, and agreed that non-availability of capital grants commensurate with its expansion during last few years has created a bottleneck in its growth and development of requisite infrastructure. Specifically, when apprised that University faculty are still using the Computer systems most of which are as old as a decade and half, the Committee earnestly directed that University should phase out the old systems at the earliest subject to availability of grants, so that huge amount being spent on their upkeep can be avoided. Good evening. I note with great disappointment that the comments made by me have not been recorded. I further wish to state that this is not the first time that I see such differences between what was discussed at a meeting and what is recorded in the Minutes - I had pointed this out to you at the end of the FC meeting as well.

For your reference, kindly note my four observations made at/with reference to the 61st FC meeting:

- 1. I had clearly stated that any expenditure incurred by the Vice Chancellor in-charge should be only as permitted by the rules and that as a safety measure such rules should be clearly indicated/attached.
- Further I had also mentioned that the Audit Objections should be tabulated under specific heads and circulated to the FC members ahead of the meeting. This has not been mentioned/recorded in the Minutes either.
- 3. In item 61.6 it is recorded that (reproduced as given in the document)

 After detailed deliberations, the committee decided to implement the allowances on revision of dearness allowance from 46% to 50% after separate approval from UGC or Ministry.

I feel that it should read as follows:

After deliberations it was decided <u>not to implement</u> the revised Dearness Allowance from 46% to 50% <u>till</u> clear instructions were received from the UGC or Ministry.

4. With reference to item no 61.9 I had recommended that a letter be sent to the Ministry or that the representatives from the University meet with the concerned officials to impress upon the GoI/Ministry/UGC the urgency in (a) appointing a permanent Vice Chancellor, (b) indicating the several problems faced by the University and (c) specifically getting the permanent posts filled at the earliest. This is not mentioned in the Minutes.

Considering the above points it is not possible for me to grant my approval for the Minutes of the 61st FC meeting as circulated.

Further, I shall be forced to raise the matter of improper recording of minutes, and lack of coordination in the University's administrative offices, with the appropriate authorities in writing or when I meet with them.

As per Statute 11(1) of the Pondicherry University, the Executive Council shall consist of the following members, namely: -

- i. Vice-Chancellor;
- ii. One Director by rotation according to seniority to be nominated by the Vice- Chancellor;
- iii. Two Deans of Schools by rotation according to seniority to be appointed by the Vice-Chancellor;
- iv. One Head of the Department of the University who is not a Dean, to be nominated by the Vice-Chancellor by rotation according to seniority;
- v. One Professor, who is not a Dean or Head by rotation according to seniority to be appointed by the Vice-Chancellor;
- vi. One Reader who is not a Head by rotation according to seniority to be appointed by the Vice-Chancellor;
- vii. One Lecturer, by rotation according to seniority, to be appointed by the Vice-Chancellor;
- viii. Three persons from amongst the Principals/Directors of the Colleges/Institutions admitted to the privileges of the University to be nominated by the Vice-Chancellor by rotation;
 - ix. Four persons of distinctions in academic and/or public life to be nominated by the Visitor.
 - x. A Central University Vice-Chancellor or Pro Vice-Chancellor to be nominated by the Executive Council on the recommendation of the Vice-Chancellor of Pondicherry University.
 - xi. A Vice-Chancellor/Director of IIT/IIM or a similar teaching Central Govt. Institute to be nominated by the Visitor.

xii. A representative each of SC/ST, Minorities, Women and Persons with Disabilities shall be nominated by the Vice-Chancellor as Members, from within or outside the University. They shall hold office for a period of 3 years.

As per the directions of the Under Secretary to the Government of India, Ministry of Education, Department of Higher Education vide letter dated 20.08.2024, it is proposed to amend the Statutes and include the following in the constitution of Executive Council of Pondicherry University Statute 11(1):

The Ministry of Education has reviewed the current governance structure of the Central Universities under its preview and noted a disparity in the representation of the Ministry within the Executive Councils (EC) of these institutions. Out of 48 Central Universities, 20 have already included a representative of the Ministry in their Executive Councils, while 28 Central Universities do not currently have such representation.

- 2. To ensure uniformity in governance across all central universities, it is suggested that the Secretary (Higher Education), Ministry of Education, Government of India or his/her nominee be included as a member of the Executive Council of your University. This inclusion is critical to align the governance structures of all central universities and to facilitate more consistent collaboration with the Ministry.
- 3. Accordingly, you are requested to take necessary steps to amend the Statutes of your University to include the above representative from the Ministry as a member of the Executive Council. The amendment of the statutes be completed and submitted to the Ministry for obtaining the assent of the Visitor within 60 (sixty) days of the issuance of this letter.

Memorandum of Understanding (MOU) among Department of Higher Education, Ministry of Education (MoE), Government of India, University Grants Commission (UGC) & Pondicherry University for Financial Year 2024-25 in pursuance of the rule 229 (xi) of the GFR, 2017

This Memorandum of Understanding (hereinafter referred to as MOU) is entered into at (Place) on this 26th day of August 2024 between Department of Higher Education, Ministry of Education, Government of India, Shastri Bhawan, New Delhi - 110 001 (hereinafter referred to as MoE)

And

University Grants Commission (UGC), Bahadur ShahZafar Marg, New Delhi – 110002

And

Pondicherry University, Puducherry (hereafter referred to as the Central University) having its (MoE, New Delhi) and represented by its Vice Chancellor (Hereinafter referred to as the Central University or "the University" which term and expression shall mean and include, unless repugnant to the context, its successors, assignees, administrators of the University).

VISION, MISSION

Vision

- To serve as an enabler of societal transformation through state-of-art higher education and research that match global benchmarks by providing access, resources and opportunities.
- To become an institution of global eminence.
- Adapting to ever-changing needs of the society and industries.

Mission

To deploy globally competent resources in terms of people, infrastructure and partners through development of trained human resources, who will serve as agents of value based Societal transformation in various spheres of life enriched with technology – assisted education, research, training and cultural integration.

WHEREAS

- 1. This MOU is executed in terms of Rule 229 (xi) of the General Financial Rules, 2017 (hereinafter referred to as GFR, 2017) and the subsequent instructions issued by the Ministry of Finance, Department of Expenditure, (hereinafter referred to as MOF) with the objective of improving efficiency of the expenditure, making the action plan outcome oriented, maintaining financial discipline and measuring performance of the institution on key parameters against the targets set so as to improve its performance.
- 2. The Central University has identified its Objectives as outlined hereunder:

Objectives of the Central University:

- 2.1 to disseminate and advance knowledge by providing instructional and research facilities in such branches of learning as it may deem fit;
- 2.2 to make special provisions for integrated courses in humanities, social sciences, science and technology in its educational programmes;
- 2.3 to take appropriate measures for promoting innovations in teaching-learning process and inter-disciplinary studies and research;
- 2.4 to educate and train manpower for the development of the country;
- 2.5 to establish linkages with industries for the promotion of science and technology;
- 2.6 to pay special attention to the improvement of the social and economic conditions and welfare of the people, their intellectual, academic and cultural development.
- 2.7 As provided in the Central University Act, the University shall have the powers as follows:
 - i. to provide for instructions in such branches of learning like natural sciences, social sciences, humanities, engineering, technology and medicine as the University may, from time to time, determine and to make provisions for research and for the advancement and dissemination of knowledge;
 - ii. to grant, subject to such conditions as the University may determine, diplomas or certificates to, and confer degrees or other academic distinctions on, persons, on the basis of examination, evaluation or any other method of testing, and to withdraw any such diplomas, certificates, degrees or other academic distinction for good and sufficient cause;

- iii. to organise and to undertake extramural studies, training and extension services:
- iv. to confer honorary degrees or other distinctions in the manner prescribed by the Statutes;
- v. to provide facilities through the distance education system to such persons as it may determine;
- vi. to institute Principalships, Professorships, Associate Professorships, Assistant Professorships and other teaching or academic positions, required by the University and to appoint persons such Principalships, Professorships, Associate Professorships, Assistant Professorships or other teaching or academic positions;
- vii. to recognise an institution of higher learning for such purposes as the University may determine and to withdraw such recognition;
- viii. to appoint persons working in any other University or academic institution, including those located outside the country, as teachers of the University for a specified period;
- ix. to create administrative, ministerial and other posts and to make appointments thereto;
- x. to co-operate or collaborate or associate with any other University or authority or institution of higher learning, including those located outside the country, in such manner and for such purposes as the University may determine;
- xi. to establish such centers and specialised laboratories or other units for research and instruction as are, in the opinion of the University, necessary for the furtherance of its objects;
- xii. to institute and award fellowships, scholarships, studentships, medals and prizes;
- xiii. to establish and maintain colleges, Institutions and Halls;
- xiv. to make provision for research and advisory services and for that purpose to enter into such arrangements with other institutions, industrial or other organisations, as the University may deem necessary;
- xv. to organise and conduct refresher courses, workshops, seminars and other programmes for teachers, evaluators and other academic staff;

- xvi. to appoint on contract or otherwise visiting Professors, Emeritus Professors, Consultants and such other persons who may contribute to the advancement of the objects of the University;
- xvii. to confer autonomous status on a College or an Institution or a Department, as the case may be, in accordance with the Statutes;
- xviii.to determine standards of admission to the University, which may include examination, evaluation or any other method of testing;
- xix. to demand and receive payment of fees and other charges;
- xx. to supervise the residences of the students of the University and to make arrangements for promoting their health and general welfare;
- xxi. to lay down conditions of service of all categories of employees, including their code of conduct;
- xxii. to regulate and enforce discipline among the students and the employees, and to take such disciplinary measures in this regard as may be deemed by the University to be necessary;
- xxiii.to make arrangements for promoting the health and general welfare of the employees;
- xxiv. to receive benefactions, donations and gifts and to acquire, hold and manage, and to dispose of, with the previous approval of the Central Government, any property, movable or immovable, including trust and endowment properties, for the purposes of the University;
- xxv. to borrow, with the previous approval of the Central Government, on the security of the Property of the University, money for the purposes of the University; and
- xxvi. to do all such other acts and things as may be necessary, incidental or conducive to the attainment of all or any of its objects. The University shall, among other measures which may be necessary for the said purpose, take, in particular, the following measures, namely:—
 - (i) admission of students and recruitment of faculty shall be made on all-India basis;
 - (ii) admissions of students shall be made on merit, either through Common Entrance Tests conducted individually by the University or in combination with other Universities, or on the basis of marks obtained in the qualifying examination in such courses where the intake of students is small;

- (iii) Inter-University mobility of faculty, with portable pensions and protection of seniority, shall be encouraged;
- (iv) semester system, continuous evaluation and choice-based credit system shall be introduced and the University shall enter into agreements with other Universities and academic institutions for credit transfer and joint degree programmes;
- (v) innovative courses and programmes of studies shall be introduced with a provision for periodic review and restructuring;
- (vi) active participation of students shall be ensured in all academic activities of the University, including evaluation of teachers;
- (vii) accreditation shall be obtained from the National Assessment and Accreditation Council or any other accrediting agency at the national level; and
- (viii) e-governance shall be introduced with an effective management information system

Now, Therefore, the parties here to express their common understanding as under:

A) MoE/UGC shall:

- i. Provide financial support to Central University to meet its recurring and nonrecurring liabilities in such manner and on such conditions as prescribed by the Government of India (hereinafter referred to as GOI) from time to time.
- ii. Help raise other resources, including loan from HEFA for expansion of infrastructural facilities, which has a direct bearing on the performance of Central University as committed in this MOU and Pondicherry University Act, 1985.
- iii. Provide guidance and advice in administration, financial, legal and such other matters as Central University require in fulfilling its objectives, stated at 2 of the MOU.
- iv. Provide support in obtaining necessary clearances and approvals, as and when required, from various Ministries, Departments and Agencies of the Central / State Governments.
- v. Provide support in resolving any dispute with any other authority of the Central/State Government as and when required.

B) Without prejudice to what has been stipulated in Central University Act (1985), as amended from time to time and the Statutes framed there under, Central University shall comply with:

- i. The provisions of the GFR, 2017, including the instructions on financial advice for autonomous bodies, as mentioned in Rule 229(viii) and those concerning release of grants-in-aid, submission of audited accounts, performance report etc.
- ii. Guidelines issued by the Central Vigilance Commission (CVC) in matters of vigilance and disciplinary proceedings etc.
- iii. instructions issued by the Ministry of Foreign Affairs / Department of Expenditure, Ministry of Finance or any other instructions from time to time with regard to foreign travel as well as those issued by the Ministry of Home Affairs (hereinafter referred to as MHA) with regard to availing/extending foreign hospitality.
- iv. Uniform accounting procedure in accordance with the guidelines issued by Ministry of Finance.

C) Central University shall also ensure following in consultation with the approval of its Statutory Bodies:

- i. Finalize any understanding or MOU with any other party including similar organizations abroad with prior approval of the competent authority of the University.
- ii. Have clearly defined 'Delegation of Powers' for deciding all administrative and financial matters.
- iii. Shall plan and prescribe courses of study for degree, diploma, and certificate or for any other purposes as mentioned in Pondicherry University's Act No. 53 of 1985.
- iv. Ensure that the post of officers of the University Section/Clause II of Pondicherry University Act, 1985 will be filled as per eligibility criteria laid out in recruitment rule and specified by Central University's EC/BoM from time to time.
- v. Ensure that all its accounts are audited by internal auditors regularly and formal audit by the C&AG.
- vi. Shall adopt the Public Financial Management System (PFMS) for receipt of funds from Govt. of India and make payments from these

- funds through PFMS only. Thus, Central University will be mandatorily fully PFMS EAT module compliant.
- vii. Present an outcome budget along with annual action plan so that it can be dovetailed in the outcome budget of MoE.
- viii. Comply strictly with the timelines for submission of annual reports and annual audited accounts to the MoE for the purpose of being tabled in Parliament by the stipulated date mentioned in Central University's Act.
 - ix. Forward to MoE any information required by it to satisfy and requirement related to Parliamentary Matter, RTI, Public Grievances, VIP References, Court Cases, Notices from Commissions and Statutory Authorities and also inputs for formulation of any policy.

- iii. The University has made the commitment of performance evaluation targets based on assumptions in respect of release of grants from the Govt. of India and raising of other resources including internal sources which have a direct bearing on the performance of the Institutions committed in this MOU.
